

## A Witness of Jesus Christ

Witness of Jesus Christ:

**BACKGROUND:** It was May 1993, I held a demanding executive position with the state, I was married (since 1981) and had two children, a six year old boy and a 3 year old girl. Since around 1990 my wife had been acting mean, troubled and less conscientious about taking care of the kids. She was a pharmacist by training and trade but at this time was not working much and was mainly a stay at home mother. Unbeknownst to me my wife had taken up with a married man and plotted a divorce that they felt would give them a lot of money, custody of the kids and monthly income. One day a man came into my office and introduced himself. I offered him coffee and was welcoming and polite. He then served me with divorce papers and left. She wanted full custody of the children and major portions of substantial assets. I was so shocked and sickened I almost threw up. The following weeks were a nightmare (as was actually the whole year). The children's lives, and mine, were in turmoil. Their lives were ripped apart and they showed it emotionally and physically. Amazingly many times my wife and her boyfriend would have romantic liaisons while leaving the children with the boyfriend's wife!

**ISSUE:** I never for a moment thought that my children would be better off with her than me so the legal wrangle became a custody fight from the beginning. I had great difficulty finding any good attorneys to take my case. They would not take my case because they felt court bias against an executive father and for a stay at home mother were impossible odds. The very best custody attorney in town would not take it. I ended up getting one that was OK. I immediately filed a motion seeking the kids for half the time during the course of the divorce battle. Without even reviewing my wife's adulterous behavior and bizarre handing of the children, the judge ruled against me and only gave me 4 days/month with my kids! The result was terrible for the children. I had done nothing wrong, my wife had done everything wrong by biblical standards yet my kids were taken away from me to be trashed by two immoral people. In a "no-fault" divorce court morality was not important. I never imagined the feeling of such unjust persecution, my wife sleeping with a married man and I deprived of my children! I had always been a Christian and prayed since

childhood and particularly prayed through the divorce but following this overwhelming unrighteous judgment against me I prayed like never before.

**DIVINE EVENT:** One evening about this time I rested on my knees by the bed and prayed virtually non-stop for 8 hours. Some of that time I even prayed out loud in a voice and language, so it seemed to me, was not my own. This has never happened before or since. At one point I heard my wife laughing downstairs at my obvious agony. I prayed on. At that point Jesus appeared to me (that is my assumption, he made no identification) about ten feet away. His image was from the chest up with a bright white light surrounding him. The image was robed, near shoulder length dark hair, and a beard of moderate length. I felt a peace and happiness more complete than I have ever experienced. I felt this way whenever I was in the light. If I swayed my torso out of the light my feelings would immediately return to the despair I felt all evening. After being there a few minutes He said "You will have the children." His image remained in the air for a few more minutes in silence then He and the light disappeared. I stayed on my knees in stunned incomprehension.

**OUTCOME:** I fought on with all my ingenuity, emotional strength and savings. In time court-appointed specialists began to see some of my attributes and some of her serious parental failings. My case strengthened and the town's best custody attorney took my case. Soon after that my wife and her boyfriend asked to see me privately. I met with them and they offered me sole legal and physical custody of the children in exchange for a large sum of money. My prayer was answered. I agreed to their terms, and, 10 months after Jesus' visit I had my children. I raised them through college. The pleasure of parenting the children was immeasurable and I am delighted beyond all expectations on their extraordinary accomplishments and presence as admirable adults.




